MPSVV AND VIKRAM UNIVERSITY

This memorandum of understanding is executed

Maharshi Panini Sanskrit Evam Vedic Vishwavidyalaya (MPSVV) was established in the year 2008 by the government of Madhya Pradesh. The sole motto of its existence was the expansion and propagation of Sanskrit language and literature. Its main objective is to rejuvenate, cherish and disseminate the universal values, knowledge and wisdom presented in Sanskrit language and literature. (Hereinafter referred as MPSVV).

AND

Vikram University was established in Ujjain on 1 March 1957 by The state of Madhya Pradesh was formed in 1956, and Madhya Bharat was merged into it. The Act relating to the University was accordingly amended. The amended Act of Vikram University No. 13, 1957 was published in Madhya Pradesh Gazette on 16 August 1957.

1. Maharshi Paninini Sanskrit Evam Vedic Vishwavidyalaya is committed to work in four (4) dimensions: Teaching, Training, Research and Extension. The university encourages and promotes innovation, research and discovery in all fields of Sanskrit learning. It takes appropriate measures for promoting inter-disciplinary studies and research in the university and other such congenial activities at the university level.

2. Vikram University has been formed exclusively for the development of Sanskrit language. Sanskrit has a glorious, scientific, literary,

cultural tradition and heritage. Its contribution in the area of prose, poetry, drama, dance, sculpture, paintings, fine arts, medicines, philosophy and other allied areas is far more extensive and lasting

1. Objectives

The goal of this MoU is to foster collaboration, provide opportunity for global experience and to facilitate advancement of knowledge on the basis of reciprocity, best effort, benefit and frequent interactions. Both universities agree.

- (a) To exchange information on research and educational programmes.
- (b) To exchange information on teaching, learning, material and other literature relevant to their educational and research programmes.
- (c) To arrange joint teaching, training and extension activities and exchange of scholars professors and other staff.
- (d) To jointly organize short-term continuing education programs on topic of mutual interest and to invite each other's faculty to participate therein.
- (e) To jointly propose and engage in research or training programmes sponsored by funding agencies and to invite each other's faculty to participate therein.
- (f) To jointly organise seminars, conferences or workshops on topics of mutual interest and to invite each other's faculty to participate therein.
- (g) To collaborate in cultural, social and co-curricular programmes.

The universities (MPSVV & VIKRAM UNIVERSITY) further agree that detailed terms and conditions that guide each activity identified

above will be appropriately determined and agree upon by the two institutions. This term shall include a technical description of the proposed activity, arrangements and persons responsible for its implementation.

2. Area of Association

This memorandum of understanding is intended to express the broad understanding of the parties hereinto, regarding their association with each other in order to extend mutual benefit.

3. Areas of Cooperation

The parties shall co-operate in the following areas:-

- (i) Collaboration towards organising joint seminars/conferences/workshops/FDP.
- (ii) Collaboration for joint Research Projects.
- (iii) Collaboration for joint Research Journals.
- (iv) Certificate Diploma/Courses in Sanskrit language.
- (v) Certificate Diploma/Courses in Yoga.
- (vi) Student exchange programmes.
- (vii) Faculty exchange programmes.

4. Roles and Responsibilities

The role and responsibilities will be on case to case basis and anything arising out of MOU will be decided on case-to-case basis by both universities.

5. Financial Arrangements

Both universities (MPSVV and VIKRAM UNIVERSITY) understand that all financial agreements between the parties have to be further negotiated and mutually agreed and will depend on the availability of funds. Both parties may seek financing of joint activities from internal and external sources available to them.

6. General Coordinators

Each University shall designate an administrative office to oversee and facilitate the implementation of any agreement arising out of this MOU. These offices are:-

7. Intellectual Property

Maharshi Panini Sanskrit University Ujjain and Kavikulguru Kalidas Sanskrit University Ramtek agree to respect each other's right to intellectual property. Further the Intellectual Property Rights that arise as a result of any collaborative research or activity under this MoU will be worked out on a case-by-case basis and will be consistent with the officially laid down policies of the two institutions.

8. Legal Relationships

This MoU shall be construed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall create any legal relationship between the parties.

There should be no dispute regarding any aspect of academic cooperation. However, if there is any, The Maharshi Panini Sanskrit and Vedic Vishwavidyalaya and Kavikulguru Kalidas Sanskrit University will jointly resolve the dispute in spirit of Independence, mutual respect and shared responsibility.

9. Commencement Renewal And Termination

This MoU will be effective from the date of the last signature here to and will remain in force for a time period of Three (3) years with a possibility for renewal at the end of the Three year period, subject to the parties' written agreement. Either party may terminate this MoU by giving three (3) months notice in writing to the other party.
