## FACULTIES AND ASSIGNMENT OF SUBJECTS TO THE FACULTIES

( Refer sections 24 (iii) and 33 (j) of the Act)
(For the purpose of this Statute, the Act means Maharshi Panini Sanskrit Evam Vedic Vishwavidyalaya Adhiniyam 2006 (15 of 2008))

1. The following shall be the faculties and subjects assigned to the faculties:-

- 2. Each faculty shall consist of the following members, namely:-
  - (a) the Dean of the Faculty—CHAIRMAN
  - (b) all Professors in the University Teaching Departments in the subjects assigned to the Faculty.
  - (c) one College Professor from each subject assigned to the Faculty.
  - (d) two Principals, other than College Professors of affiliated Colleges teaching any of the subjects assigned to the Faculty.
  - (e) one Reader of University Teaching Departments in any of the subjects assigned to the faculty.
  - (f) three Lecturers teaching any of the subject assigned to the Faculty.
  - (g) one person nominated as members of the faculty by the Academic Council from amongst its members.
  - (h) not more than two persons not connected with the University or any of its constituent or affiliated colleges and having expert knowledge of the subject or subjects assigned to the Faculty, co-opted by the Academic Council.

The members under clause (c), (d), (e) and (f) shall be nominated by the Vice-Chancellor.

- 3. Faculties shall be constituted for a term of three years. The term of the Dean and Members appointed in the beginning of the term or during the term or otherwise shall be co-terminous with the term of the Faculty.
- 4. One-third of the total membership of the Faculty shall constitute a quorum.
- 5. The Dean of each Faculty shall be appointed by the Vice-Chancellor for a period of the three years from amongst the Professors of University Teaching Departments who are teachers in the subjects assigned to the Faculty.

Provided that if there is no Professor of the University Teaching Departments teaching the said subjects, the Dean shall be appointed from amongst the College Professors who are teachers in the said subjects.

Provided further that if there is no Professor of the University Teaching Departments or College Professor teaching the said subjects, the Dean shall be appointed from amongst the Principals of affiliated colleges, who are teachers in said subjects, but who are not College Professors.

Provided Further that if there is no Professor of University Teaching Departments or College Professor or Principal teaching the said subjects, the Vice-Chancellor may appoint Dean of any other faculty to act as the Dean of the Faculty.

- 6. The Dean shall be Chairman of the Faculty and shall be responsible for the due observance of the rules relating to the Faculty and for the conduct and maintenance of standards of teaching and research.
- 7. Subject to the provisions of the Act each Faculty shall have the following powers, namely
  - (a) subject to the control of the Academic Council, to organize, co-ordinate and regulate teaching and research activities of the subjects assigned to the Faculty.
  - (b) to approve the scheme of the examinations and the courses, curriculum and syllabi for the different examinations in the subjects assigned to the Faculty as proposed by the different Subject Committees of the Faculty.
  - (c) to recommend to the Academic Council the conditions for the award of the degrees, diplomas and other distinctions including the scheme of examinations for the different degrees.
  - (d) to deal with such other matters relating to the subjects within its purview as may be referred to it by the Academic Council, or the Vice-Chancellor.
  - (e) to hold meetings with the approval of the Vice-Chancellor jointly with any other Faculty or Faculties, such joint meetings to be convened and presided over by a Dean nominated by the Vice-Chancellor.
  - (f) such other powers as may be assigned to it by the Ordinances.

Statute No.15

8. For each of the subjects assigned to a Faculty, a Subject Committee shall be constituted. The members of the Subject Committee for a subject shall be as follows:-

- (i) Dean of the Faculty to which the subject is assigned Chairman
- (ii) From among the teachers teaching the subjects assigned to Faculty either in University Teaching Departments or in affiliated Colleges, three teachers to be nominated by the Vice-Chancellor for a term of three years.
- (iii) One expert in each subject, not connected with the University to be nominated by the Vice-Chancellor for a term of three years.

Three members of the Subject Committee shall constitute a quorum.

The term of members of the Subject Committee shall be co-terminous with the term of the Faculty.

- 9. The Subject Committees shall meet before the meeting of the Faculty is held, to frame the scheme of all the examinations and the courses, curriculum and syllabi for the subject concerned.
- 10. The scheme of the examinations and the courses, curriculum and syllabi prepared by the Subject Committees shall be placed in the next meeting of the Faculty. The Faculty may approve the proposals as such or modify them.

The scheme of the examination and the courses, curriculum and syllabi prepared by the Subject Committee and approved by the Faculty shall be in force for the whole course for a candidate, for example, for three years for three year degree course and for two years for two year post-graduate course. Only in case of emergency, any change shall be permitted by the Faculty.

Provided that the schemes of the examinations and the syllabi for the examinations which were being conducted by the different University of M.P. for the various affiliated colleges, before the enforcement of the Act, shall be continued till the schemes of examinations and the courses, curriculum and syllabi are framed and introduced by the University.

11. The Vice-Chancellor shall be authorized to take any decision on any matter not covered herein.
